1. CALL TO ORDER/INTRODUCTIONS

DAC Chairperson Jaqueline Gonzalez called the meeting to order at 6:02 p.m. and welcomed everyone. 2. SCHOOL INTRODUCTIONS

Principals of Silver Wing and Vista Square Elementary presented highlights of their schools.

3. SUPERINTENDENT'S REPORT

Superintendent Dr. Francisco Escobedo commended school administrators, teachers, and support staff for a job well done getting our schools ready for Hybrid Reopening. He shared of the District's plan to begin 100% in-person instruction for the 2021-2022 school year and added the District is also proposing a virtual academy for next school year and that parents will be receiving a survey the following week to gather comments and ideas regarding this option. Dr. Escobedo announced that in his newsletter recently sent out to the school community that August will be his final month with the District.
